

**Home Office Makeover Giveaway
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. BY PARTICIPATING IN THIS SWEEPSTAKES, ENTRANTS AGREE TO BE BOUND BY THESE OFFICIAL RULES.

- 1. OVERVIEW.** Sectigo's **Home Office Makeover Giveaway** (the "**Sweepstakes**") begins at 12:00:00 AM Eastern Standard Time ("EST") on April 12, 2021 and ends at 6:00:00 PM EST on May 20, 2021. ("**Sweepstakes Period**").
- 2. ELIGIBILITY.** Open to attendees of the 2021 **RSA Conference** who are residents of the 50 United States and D.C., 21 years of age and older as of the start date of the Sweepstakes, except for employees of Sectigo Limited ("**Sponsor**"), and Sectigo, Inc. ("**Administrator**") and their respective affiliates and subsidiaries (collectively "**Promotion Parties**"), and members of their immediate family or persons living in the same household. Void where prohibited.
- 3. HOW TO ENTER.** During the Sweepstakes Period, eligible participants must schedule a qualified demo with Sectigo by: (i) completing a "Request a Meeting" form in Sectigo's virtual booth during the RSA Conference, or (ii) schedule a demo through Sectigo.com/RSA2021, during the Sweepstakes Period. A demo shall be considered "qualified" if it is scheduled and attended by a decision maker responsible for the administration of an organization's certificate infrastructure. The maximum number of entries per eligible participant is one (1). By submitting an entry form, entrant is agreeing to these Official Rules. Entries become the property of Sponsor and will not be returned. Entries must be received during the Sweepstakes Period. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.
- 4. DRAWING.** A random drawing will be conducted on or about May 21, 2021 by Administrator. Odds of winning are randomized and based on the number of entries received. By entering this Sweepstakes, entrant accepts and agrees to these Official Rules and the decisions of the Administrator, which shall be final in all matters.
- 5. NOTIFICATION.** Winners will be notified by e-mail, mail or by phone and must sign and return any required Affidavit of Eligibility, a Liability Waiver and Release, and/or Travel Release within ten (10) days of the date notice is sent or such other date set by Sponsor. Failure to respond within the applicable time period will result in forfeiture of prize and Sponsor shall have the option to award the prize to an alternate winner.
- 6. CONDITIONS.** All federal, state, local and income taxes resulting from acceptance of a prize are the responsibility of the winner.
